## TERMS AND CONDITIONS

### 1. Deposit, Payment of Purchase Price, Fees

Buyer has paid a non-refundable deposit of \$ \_\_\_\_\_, with payment of the balance of \$ \_\_\_\_\_ due. Payment of the balance may be made by cash, cashier's check, money order, cash app, or PayPal (3% surcharge applies). If payment plan agreed upon then payment dates and amounts will follow.

If payment plan is chosen, the puppy/dog may be released to Buyer, but registration papers can be help until full payment is received. If full payment or payment plan schedule is not complied with, Seller has the right to take puppy/dog back into Sellers's possession with no refund, legal action may be applied.

Buyer acknowledges and agrees that Buyer will forfeit the deposit and any rights to the Dog if:

- (a) Buyer fails to complete the purchase of the Dog for any reason, or
- (b) Buyer fails to pay the balance of the Purchase Price ( \_\_\_\_\_ )

### 2. Transfer of Ownership and Registration

Upon payment in full of the Purchase Price, Seller (at Seller's sole cost) shall promptly take all actions required to officially transfer ownership and registration (if any) of the Dog to Buyer.

### 3. Seller's Representations and Warranties

Seller represents and warrants to Buyer that:

- (a) Seller is the legal and true owner of the Dog, and that Seller has full right and authority to sell the Dog.
- (b) The Dog is being sold free and clear of any lien, security interest, charge or other encumbrance.
- (c) Seller guarantees that the Dog is a purebred dog, offspring of the purebred sire and purebred dam set out on page 1 of this Agreement.
- (d) The Dog is in good health and free of communicable diseases at the time of this sale. Buyer has 3 business days from the delivery date to have the Dog examined by a licensed veterinarian, at Buyer's sole cost. If the Dog fails the examination, Buyer may return the Dog, with a written statement from the veterinarian, for a full refund. Failure by Buyer to have the Dog examined

within the 3-day period will nullify this warranty. If Buyer chooses to keep the puppy, no replacement will be given, and all medical costs and treatment are sole responsibility of the Buyer. This health guarantee will be null and void.

(e) This Guarantee does NOT cover Cherry eye, Minor worms, Entropion, Ectropion, Allergies, undescended testicles, loose knees or hips, Stenotic nares, elongated soft pallet, umbilical hernia, dermatitis, demodectic mange. Seller will NOT replace a puppy due to heat stroke, abuse/neglect, or improper socialization. Buyer agrees that they have thoroughly researched the American Bully breed and understand the many health issues they can possess. Buyer is responsible for all medical costs of their puppy. (No refunds will be given) This guarantee covers only the original Buyer and is not transferable.

(f) If ear cropping is done, there is no guarantee that ears will stand erect, if buyer pays to have seller find an ear cropper, no guarantee that the ears will be the exact shape or size as other dogs.

(g) To ensure that Buyer does not euthanize the Dog or take it to an animal shelter, Seller will take the Dog back at any time during the Dog's lifetime. Seller will not issue a refund or provide another Dog to Buyer unless the Dog's return was a result of any misrepresentation on the part of Seller with respect to the Dog's health.

#### **4. Fitness of Purpose**

The Dog was bred as a companion animal, and Seller does not provide any warranty as to the Dog's fitness for any specific purpose, including obedience trials, show ring performance, and/or breeding purposes

#### **5. Limitation of Action**

Any action or claim brought by Buyer against Seller for breach of this Agreement or for loss due to negligence must be brought within one (6) months of the date such claim or loss occurs. Ask seller about options to extend health guarantee.

#### **6. Entire Agreement**

This Agreement represents the entire agreement between the parties. Seller and Buyer have made no other agreements, promises, representations or warranties, express or implied, unless specifically stated in this Agreement. **Written acknowledgment and agreement of this contract whether through text, email, social media, or any other communication platform can be used as contract signature.**
